**PETITION TO EXPUNGE OR SEAL**

**NOTICE TO PARTIES WHO ARE NOT REPRESENTED BY AN ATTORNEY WHO IS A MEMBER IN  
GOOD STANDING OF THE FLORIDA BAR**

This package is designed to help persons seeking to represent themselves in court without the assistance of an attorney. It is meant to serve as a guide only.

We do not guarantee that either the instructions or the forms will achieve the result desired by the parties or ensure that any individual judge will follow the procedures exactly or accept each and every form drafted. Any person using these instructions and forms does so at his/her own risk.

Please note that Florida law prevents our staff from providing legal advice.

The Clerk of the Circuit Court cannot assist you in the filing of your application for sealing or expungement of your criminal history records. You may wish to contact an attorney to assist you in this complex procedure. If you choose to represent yourself, you may want to research the Florida Statutes and the Rules of Criminal Procedure, which govern expungement or sealing of criminal records.

You must have the original Certificate of Eligibility from FDLE to file the Petition to Expunge or Seal. **Note:** **The certificate is valid for one year from the date stamped on the certificate by FDLE.**

Complete the following forms:

- Petition to Expunge or Seal
- Affidavit in Support of Petition to Expunge or Seal
  - Sign this completed form before a Notary Public or a Deputy Clerk
- Receipt for Copy of Petition to Expunge, Certificate of Eligibility, and Affidavit in Support of Petition to Expunge (State Attorney – Hand Delivery)
- Objection/Consent of Office State Attorney
- Receipt for Copy of Petition to Expunge, Certificate of Eligibility, and Affidavit in Support of Petition to Expunge (Arresting Agency – Hand Delivery)
- Objection/Consent of Arresting Agency
- Order to Expunge Under Section 943.0585, Florida Statutes, and Florida Rules of Criminal Procedure, 3.692

OR,

- Order to Seal Records Under Section 943.059, Florida Statutes, and Florida Rules of Criminal Procedure, 3.692
- 

Deliver the following to the State Attorney:

- a copy of the Petition to Expunge or Seal,
- a copy of the Certificate of Eligibility,
- a copy of the signed notarized Affidavit in Support of Petition to Expunge or Seal,
- the original Objection/Consent of Office of State Attorney,

- the original Receipt for Copy of petition to Expunge, Certificate of Eligibility, and Affidavit in Support of Petition to Expunge (State Attorney – Hand Delivery),
  - wait for the Receipt to be signed,
  - the signed Receipt needs to be filed with the original Petition at the Lake County Clerk of Court’s office.

Deliver the following to the Arresting Agency:

- a copy of the Petition to Expunge or Seal,
- a copy of the Certificate of Eligibility,
- a copy of the signed notarized Affidavit in Support of Petition to Expunge or Seal,
- the original Objection/Consent of Arresting Agency,
- the original Receipt for Copy of petition to Expunge, Certificate of Eligibility, and Affidavit in Support of Petition to Expunge (Arresting Agency – Hand Delivery),
  - wait for the Receipt to be signed,
  - the signed Receipt needs to be filed with the original Petition at the Lake County Clerk of Court’s office,

Deliver the following to FDLE by U.S. Certified mail or hand delivery:

- a copy of the Petition to Expunge or Seal,
- a copy of the Certificate of Eligibility,
- a copy of the signed notarized Affidavit in Support of Petition to Expunge or Seal.

File the following with the Clerk of Court with the appropriate filing fee: (Make a copy of the following for your records prior to filing with the Clerk.)

- the original Petition to Expunge or Seal,
- the original Certificate of Eligibility,
- the original notarized Affidavit in Support of Petition to Expunge or Seal,
- the original Receipt for Copy of petition to Expunge, Certificate of Eligibility, and Affidavit in Support of Petition to Expunge (State Attorney – Hand Delivery),
  - signed by a recipient of the State Attorney’s Office,
- the original Receipt for Copy of Petition to Expunge, Certificate of Eligibility, and Affidavit in Support of Petition to Expunge (Arresting Agency – Hand Delivery),
  - signed by a recipient of the arresting agency,
- the original Order to Expunge or Order to Seal.

If you have not received a copy of the Order to Expunge or Seal within 30 days of filing your Petition with the Clerk of Court,

- review your case on the Clerk’s website [www.lakecountyclerk.org](http://www.lakecountyclerk.org) to determine the status of your case.

If an objection has been filed by either the State Attorney or Arresting Agency, you will need to schedule a hearing with the judge assigned to your case.

- Contact the judicial assistant and schedule a hearing.
- Complete the Notice of Hearing on the Florida Courts website, [www.flcourts.org](http://www.flcourts.org); under the bullet Self-Help, select Family Law Forms, scroll down to Form 12.923, select the PDF version, and complete the blanks on the form.
- Mail the Notice of Hearing to the parties required to attend the hearing.
